Aransas-Corpus Christi Pilot Work Hours Audit Report

On Friday, May 29, 2015 Mr. John Pasch, audited the Pilot's master work hours logbook for the second quarter 2015 as required by the Resolution adopted 12 August 2014 by the Board of Pilot Commissioners for the Port of Corpus Christi Authority. That resolution amended the Pilotage Rule and Regulations by limiting a Pilot's work hours to not more than 13 total hours in any 24 hour period.

This audit was performed with the Pilot's Presiding President, Capt Louis Adams, Capt Jay Rivera and Ms. Kristin Malone. The pilots are using a new, computer based data base that presents a professional display and electronically monitors the pilots work hours. Several pilots' work records were reviewed, including the complete two week work cycle of several randomly selected pilot.

No discrepancies were noted during the audit of pilot work-rest hours. The next audit is scheduled for the third quarter in 2015.




